fastening system: by means of laces and a lateral internal zipper;

processing: Ago;

outsole: black rubber marked "REPLAY" (B300028301A);

upper:

- black recycled leather with thickness declared 1,4-1,6mm (B100012901A);

- black Nylon fabric coupled with grey foam and black Lycra fabric (B200022501A); heel/toe upper: black recycled leather with thickness declared 1,4-1,6mm

(B100012901A) coupled with white TPU (B300026604A);

upper insert: black webbing, green marked "REPLAY EST. 81" (B200022601A);

vamp lining: black mesh coupled with grey foam and black knitting (B200021701A); rear/quarter lining: black pig skin PU (B200022701B) coupled with black knitting and

black Lycra fabric;

heel-grip: black suede microfiber (B200021801A);

insole: grey PU material (B300026207A);

removable insock (not perforated): green recycled slow recovery foam coupled with black mesh, white marked "REPLAY / Ortholite" in the rear area (B300026112A);

Insole and insock are glued together.

The boot has stiff inserts in polymeric material inserted into the upper, as follows: external/internal ankle insert/padding: black PVC (B300026401A) matched with grey

foam (B300026307A) and white fabric (B200021904A).
